

### Frequently Asked Questions (FAQs):

#### 1. Can foreigners register a company in Argentina?

Yes. Foreigners can fully own and operate companies in Argentina. There are no citizenship or residency requirements for shareholders. However, at least one local directormay be required.

### 2. Do I need to travel to Argentina to register a company?

No, we handle all the proces, end-to-end without asking the investor to travel to Argentina.

#### 3. What types of companies can be registered?

The most common structures for foreign investors are:

- Sociedad de Responsabilidad Limitada (SRL) Limited Liability Company
  - 2 to 50 partners
  - Liability limited to capital contribution
  - Simpler administration
- · Sociedad Anónima (SA) Corporation
  - Minimum 2 shareholders (or 1 if a sole shareholder SA)
  - Liability limited to capital contribution
  - Preferred for raising investment or listing shares
- Sucursal de empresa extranjera Branch of a foreign company
  - Registered in Argentina but fully dependent on the parent company
  - Must have a legal representative in Argentina

### 4. How long does the registration take?

• SRL: 3–4 weeks

• SA: 4-6 weeks

Delays can occur if client's documentation is incomplete.

### 5. What are the minimum capital requirements?

Our team will assist in the minimun capital requiremts, this might change based on the company activity and type of entity.

The law requires certain minimum numbers (usually low in USD for S.R.L. type), but our expert might advice you to formalise it with a 30% or 40% more in order to gain rapidaly approval and avoid objections from the justice.

### 6. What taxes do companies face in Argentina?

- Corporate Income Tax: up to 35%
- · Value Added Tax (VAT): 21% standard rate
- Gross Income Tax: Provincial tax (varies by jurisdiction)
- Social Security Contributions: For employees

# Frequently Asked Questions (FAQs):

### 7. Can a foreign company repatriate profits?

Yes. Dividends can be repatriated, withholding tax on dividends is generally 7%.

### 8. Can I do business immediately after registration?

Yes, once you obtain the CUIT (tax ID) and register for VAT and municipal permits (if applicable). Opening a bank account is essential for commercial operations.
